# 4) Treasurer's report and presentation of 2021/22 accounts

Copies of the accounts prepared by Brown Butler (Leeds Chartered Accountants) for the year ended 31 March 2022 are available for inspection if required. The Treasurer presented her report with additional information about the accounts.No questions were raised in connection with the accounts presented and the Chairman would sign these at the next available opportunity.

A question was asked if the draft accounts could be made available on the website and it was agreed that this request would be actioned.

## 5) Update on teaching and its future development

Ron Millet presented David Guild's teaching update. No questions were raised regarding the teaching update and thanks were given to David Guild for his hard work.

#### 6) Update on Yorkshire League and Online Yorkshire League

Mike Jackson presented his update on the Yorkshire League and Online Yorkshire League. A number of questions arose regarding the face to face league;

- Q) If people have to travel far, could the match be held online?
- A) The league was intended to be face to face but if both captains agree, the match could be played online. Phil Godfrey advised that York Bridge Club would be happy to host the matches as a half-way venue.
- Q) There were a couple of questions regarding teams bringing their own food and catering to dietary requirements.

- A) The intention is to return to how the league was run pre-pandemic, including home teams providing refreshments; however there could be an agreement between both teams.
- Q) If a league match was played online, would there be help setting the match up?
- A) Instructions are available on the YCBA website or email Nick Woolven.
- Q) There seems to be technological problems with Realbridge so BBO is preferred.

- Q) Will the home team have choice on whether the match is played on BBO or Realbridge?
- A) Yes, if the match is played online, the home team have the choice on which platform is used.
